

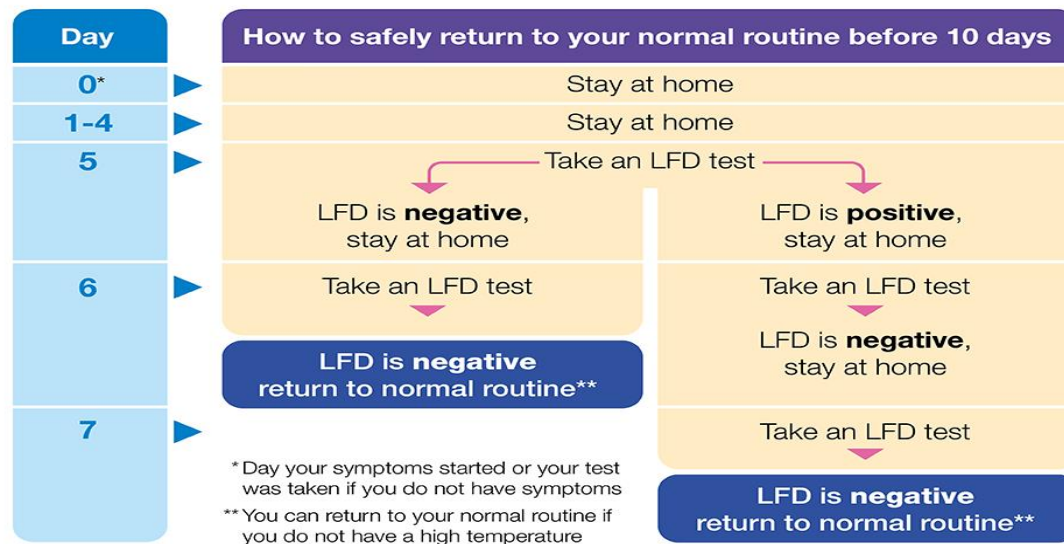

Preventing and Managing Sickness including outbreaks Risk Procedures and Risk Assessment

Progression of restrictions / Staged Response

There are 5 stages for when dealing with medical incidents / outbreaks. Depending on the nature of the situation

Response Stage – reviewed based on ongoing guidance from DfE and LCC			
STAGE 5 + (COVID-19) From September 2021	The following system controls are actions that schools must take:		
	<ol style="list-style-type: none"> 1. Ensure good hygiene for everyone. 2. Maintain appropriate cleaning regimes. 3. Keep occupied spaces well ventilated. 4. Follow public health advice on testing, self-isolation and managing confirmed cases of COVID-19.

Specific Health guidance – Shielded and clinically vulnerable children and young people and those living with a shielded or clinically vulnerable person <i>Clinically extremely vulnerable and those living with someone who is deemed to be clinically extremely vulnerable are expected to attend school.</i> PPE – PPE will be worn during cleaning. <i>Wearing a face mask in schools is not recommended. Changing habits, cleaning and hygiene are effective measures in controlling the spread of the virus.</i> <i>Mishandling of face masks can inadvertently increase the risk of transmission.</i> <i>PPE will only be required for a very small number of cases including: – this will be made up of face mask, disposable gloves, disposable apron and eye protection</i> <ul style="list-style-type: none"> • <i>When staff are assisting children in their intimate care needs</i> • <i>If a child becomes unwell with symptoms of coronavirus while in school until they can be collected to return home</i> 			
Specific Issue / Risk	Key Actions	Who	Notes
When an individual develops symptoms or has a positive test	<ul style="list-style-type: none"> - If anyone in the school becomes unwell with a new persistent cough (lasting for longer than an hour and 3/4 episodes of this in 24hrs), a high temperature, or loss of or change in their normal sense of taste and smell they must be sent home and follow the advice for households with possible confirmed cases (https://www.gov.uk/government/publications/COVID-19: people with COVID-9 and their contacts) and should follow this guidance. - If a negative result is returned, they should return to work or school. This negative result should be communicated with the school. - If this is a child, parents should be contacted immediately, and the child should be collected swiftly. - The child should be escorted by a member for staff to the isolation room and PPE equipment should be used until the child is collected. They will have access to a toilet, and this is to be deep cleaned once the child has left. PPE clothing should be placed in a bin bag and tied securely at the top for disposal after 72 hours and should not be stored with the general waste. - School will contact all parents (due to the level of cross over between bubbles) to inform them of any positive cases. 	<i>All stakeholders:</i> <ul style="list-style-type: none"> • <i>Parents</i> • <i>Teachers</i> • <i>Children</i> • <i>Headteacher</i> 	<i>The school's decision regarding symptoms is final and they should not be held responsible for any loss of education if a child is sent home with suspected symptoms and a negative test is returned.</i>
Confirmed case of COVID-19	<ul style="list-style-type: none"> - Self-isolation is for up to 10 days and should only return to school only if they have no symptoms except a cough or anosmia - <i>You should avoid all contact with other people</i> - <i>Follow the below diagram on how to return safely to school:</i> 	<i>All staff</i>	



- If staff have been in close contact with someone (live with someone who has tested positive or stayed overnight in the same household) then you are advised to follow the government guidance.
- School MUST contact PHE and Lincolnshire Health Team if a 10 or more positive tests have been confirmed
- 10 or more cases in 14 days would be deemed an outbreak and school must work with the Health Protection Team and follow all actions given.

Clean hands thoroughly more often than usual

- Children should be supervised if necessary, during handwashing to avoid ingestion of soap or sanitiser
- Use of a hand sanitiser station in playground to avoid congestion in corridor
- Sensitive cleaning skin wipes can be used if children’s skin reacts to soap or sanitiser – but these must be anti-bacterial

Cleaning & Hygiene

- Ensure that sufficient handwashing facilities are available. Where a sink is not nearby, provide hand sanitiser in classrooms and other learning environments (school hall)
- clean surfaces that children and young people are touching, such as toys, books, desks, chairs, doors, sinks, toilets, light switches, empty bins regularly
- ensure that all adults and children:
 - o frequently wash their hands with soap and water for 20 seconds and dry thoroughly.
 - o clean their hands before and after eating, and after sneezing or coughing.
 - o are encouraged not to touch their mouth, eyes and nose
 - o use a tissue or elbow to cough or sneeze and use bins for tissue waste (‘catch it, bin it, kill it’)
- ensure that help is available for children and who have trouble cleaning their hands independently
- encourage all children to learn and practise these habits through games, songs and repetition
- ensure that bins for tissues are emptied each day
- where possible, all spaces should be well ventilated using natural ventilation (opening windows- partially whilst children are in the room and fully during times when they are not in there)
- prop internal doors open, where safe to do so (bearing in mind fire safety and safeguarding), to limit use of door handles and aid ventilation
- there is no need for anything other than normal personal hygiene and washing of clothes following a day in school for children and staff.

All staff have a responsibility for this

Visitors in school	<ul style="list-style-type: none"> - Visiting agencies no longer are required to wear face coverings unless they choose to do so. - Restrictions on visiting agencies will be re-introduced if we are advised to do so by the Health Protection Team 	HT SBM

Reduce mixing within setting	<p>62% of our children have siblings in other bubbles, each class bubble have links with other class bubbles.</p> <ul style="list-style-type: none"> - Children arrive at school and separate from parent when through the car park gate. - Access to rooms should be done directly from outside where possible. - All children are to stay within their designated area on the playground during lunch and play times. - Walkways will be indicated in the school hall with a one-way system in place. The corridor to be indicated with safe distances markers for toilet / locker usage. - Staggered toilet and locker access to ensure that any corridors or circulation routes used have a limited number of pupils using them at any time - Lunch breaks – KS2 packed lunch children remain in their classrooms and bubbles for lunch 12.00-12.30. - Staggered Drop off - parents should follow the one-way system to leave site – all parents to wear a face covering – all parents with surname A-J to drop off at 8.40am and K – Z 8.50am to reduce congestion of parents at school gates - Staggered Pick up point same procedures as drop off – all parents to wear a face covering- all parents with surname A-J to drop off at 2.50pm and K – Z 3.00pm to reduce congestion of parents at school gates - KS2 child only will be permitted to walk to their parents’ car due to staffing. 	All staff responsible for ensuring social distancing is adhered to.	
Keeping small cohorts together	<ul style="list-style-type: none"> - Ensure that children are in the same groups at all times each day. - Where alternative teacher’s cross bubbles they must observe distancing guidelines. - Ensure that wherever possible children use the same classroom or area of a setting throughout the day, with thorough cleaning of the rooms at the end of the day. Same desk and same individual equipment to be used each day. - Children to sit facing forwards and side by side to reduce transmission. - Children will not be able to return of their bubble unless either a negative test result has been returned and school has been notified or they return to school after another accepted illness absence. This is only with the approval of the Headteacher. 	CT – implement HT - oversee	<p>Staggered toilet times Packed lunch will be eaten in classroom UKS2 hot meals to be eaten in class KS2 toilets –staggered use (1 bubble at a time) No paired reading between classes is to take place and no joint activities during curriculum time</p>
Class sizes and groups	<ul style="list-style-type: none"> - Classes will be re-organised into ‘bubbles’ should we be advised by Lincolnshire Health Team due to localised outbreaks. If this should happen then we will revert to: - Desks should be positioned in classrooms to ensure children face forward to the teacher seating side by side and not face to face or side on - Staggered playtimes and possible start to finish of days - Face coverings for staff in classrooms and communal areas, where distancing cannot be maintained. - Maintaining distance where possible between adults and adults to children - No whole school gatherings or key stage group choir sessions to take place until further advice has been received – assemblies should continue BUT take place in classes. - All children should have individual equipment they need for working such as pens and pencils. - Classroom based resources such as books and games should be only shared within their own bubble. - Any whole school resources that are shared should be cleaned between bubble use or left for 24hrs or 72 hrs for plastic before another bubble uses. - Children should be limited to items brought in from home and this should only be essentials – lunch boxes, coat and hat, reading books, water bottle and these can be brought in a school bag. - Lockers must only be used by that specific child only; the outer doors of lockers will be cleaned each evening by cleaning staff. Use of toilets	<ul style="list-style-type: none"> - NO CHILD IS TO BE REFUSED USE OF THE TOILET AT ANY TIME - Monitoring of use of corridors for toilet breaks to reduce congestion in corridors - Cleaning of toilets to be administered at lunchtime with use of cleaning spray on a rota basis 	All staff	

Using outdoor space	<ul style="list-style-type: none"> - For exercise and breaks - For outdoor education, where possible, as this can limit transmission and more easily allow for distance between children and staff - Outdoor equipment should not be used unless it is appropriately cleaned between groups of children using it. - Staff will need to ensure hand sanitiser, first aid grab bag, anti-bacterial wipes and metre stick (distance reminder) to be taken out during outdoor sessions if needed 	<i>All staff</i>	<i>A hand sanitising station is to be used on the playground</i>
Shared resources	<ul style="list-style-type: none"> - Resources are still not to be permitted to be shared across bubbles unless guidance is followed, which states it should be cleaned or left for 24hrs (72 hrs for plastic) before another bubble can use it. - All children to use their allocated stationery only and this will be cleaned at the end of each day 	<i>All children and staff to implement</i>	
[Other] resources	<ul style="list-style-type: none"> - Play equipment is only used when ensuring it is appropriately cleaned between groups of children using it, and that multiple groups do not use it simultaneously - Removal of unnecessary items from classrooms where there is space to store it elsewhere - Remove/restrict access to all soft furnishings, soft toys and toys that are hard to clean (such as those with intricate parts) 	<i>HT to oversee and all staff to implement</i>	
Lesson Planning	<ul style="list-style-type: none"> - Decide which lessons or activities will be safely delivered taking into account the mobility of children in classrooms and learning environments - Consider which lessons or classroom activities could take place outdoors - Staff to plan in PHSE/ Wellbeing / Mindfulness activities daily to manage a smooth transition back to school - The curriculum will remain broad and balanced where possible and gaps can also be addressed through cross curricular work 	<i>Teaching staff</i>	<i>Staff to make colleagues aware when they are taking lessons outside to deliver to ensure there is no more than 2 working groups outside at any one time (1 group field based, 1 group playground based).</i>
Administering First Aid	<ul style="list-style-type: none"> - First Aid grab bag to be taken outside whenever a bubble is out – to contain, anti-bacterial wipes, plasters, gauze, tape, gloves, apron, tissues and waste bag - If appropriate a child should be encouraged to wipe any graze, if not staff to wear gloves and administer first aid with the child looking away from them. - Staff advised if giving CPR – no rescue breaths are to be given or leaning down to check for breathing and only chest compressions until an ambulance arrives. - In choking episodes staff to administer first aid from behind which is in line with training, but they should not go near the mouth 	<i>All staff</i>	<i>Ambulance calls need to inform the ambulance crew that level 3 PPE is required</i>
Parent protocols	<ul style="list-style-type: none"> - Parents to comply with Conditions of Attendance document - All parents coming onto school site are no longer required to wear face mask on site, but we respectfully ask that you do continue to, in order to keep staff safe. - Parents should only come into the school building with for a booked appointment. - Parents MUST engage with remote learning should the school have to close in full or in part. - No secondary school aged children are to come onto site. - Parents are not to gather at the gates of school once their child has been brought onto site – this may hold up the staggered starts and pick-ups for other children and parents. 	<i>HT/ SBM to ensure information has been sent to <u>all</u> parents Acceptable Use Policy Blended/Remote Learning Policy</i>	<i>All parents to receive a copy to re-sign and return to school Awaiting guidance on school's liability should a child develop symptoms in school and whether the school can be held accountable for this</i>
Transport arrangements	<ul style="list-style-type: none"> - Encourage parents and children to walk or cycle school where possible - Making sure schools, parents follow the Coronavirus (COVID-19): safer travel guidance for passengers when planning their travel - Ensuring that their transport arrangements cater for any changes to start and finish times - Making sure transport providers do not work if they or a member of their household are displaying any symptoms of coronavirus - Making sure transport providers, as far as possible, follow hygiene rules and try to keep distance from their passengers 	<i>HT to oversee</i>	<i>Contact LCC regarding taxi firms used for transport that they are adhering to safe travel guidance</i>
